



Reg: Extension of the date for registration and preparation of electoral rolls for Constitution of a New Board of the Shiromani Gurdwara Prabhandak Committee (SGPC).

1. The process of registration of voters for the constitution of a new Board of the Shiromani Gurdwara Prabhandak Committee (SGPC) has been going on since 21.10.2023. The eligible voters for the election of the Board of the SGPC were to be registered by 15.11.2023. The dates for registration of voters were, however, extended from time to time. It was initially extended till 29.02.2024, followed by extensions till 30.04.2024, 31.07.2024 and now till today i.e., 16.09.2024.

2. The Commissioner, Gurdwara Elections, Punjab has addressed Memo No. Elec.-2024/Gurd.-122 dated 16.09.2024 to this office. It is stated therein that in the past one month it had been observed that there had been a surge in the number of applications being received for the registration of voters. This is stated as a positive indication of the voters' interest. It is, as such, mentioned that terminating the voters' enrollment process today on 16.09.2024 may deprive substantial number of persons from enrolling themselves as voters. It has, therefore, been requested that the last date for enrollment of voters be extended by another 45 days.

3. It is to be noticed that there have been several circumstances and aspects, which delayed the process of registration of eligible Sikh persons from getting themselves registered as voters. These are noted and mentioned in the memos. by which the dates for registration of eligible Sikh voters were extended. At present, there is indeed a surge amongst the eligible Sikhs for getting themselves registered as voters for the election to the new Board of the SGPC. Press reports also make a mention in this regard. In the said circumstances, the request of the worthy Commissioner, Gurdwaras Elections, Punjab is based on the actual position and circumstances at the ground level and has merit in it.

4. This office has been informed that till 27.08.2024, 41,02,508 eligible Sikh persons had got themselves registered as voters for the election

of new Board of the SGPC. At the time of granting extension for the registration of eligible Sikh persons as voters on 31.07.2024 as many as 27,87,670 application forms had been received till 26.07.2024. Some religious organizations, besides, prominent persons have also represented for extension of the last date for the registration of voters.

5. The process for the registration of voters had been somewhat steady and gradual, which is now gaining momentum. Many eligible Sikh persons are in the process of getting themselves registered as voters for the election of members of the new Board, which is to be constituted. There now appears to be interest and enthusiasm amongst the eligible Sikh persons to get themselves registered as voters. Advocates who are eligible to get themselves registered as voters have also taken an initiative to getting themselves registered as voters. This is indeed a laudable initiative on their part.

6. The Commissioners, Gurdwaras Elections, Punjab, Himachal Pradesh and the Union Territory, Chandigarh are requested to make more publicity to motivate those eligible to vote to get themselves registered as voters for the election of the SGPC Board. Besides, take administrative measures at the ground level by asking and involving the block-level officers to be proactive in getting eligible Sikh persons to get themselves registered as voters. For this process, more time would be needed so that an adequate number of eligible voters are registered as voters for the election of the SGPC Board. The request of the worthy Commissioner, Gurdwaras Elections is, therefore, liable to be accepted.

Accordingly, the last date for eligible Sikh persons to get themselves registered as voters for the elections of members for the constitution of a new Board of the SGPC is extended from today i.e., 16.09.2024 till 31.10.2024.

This is for your information and necessary appropriate action.
